Professional Service providers are hereby invited for the concrete structural scanning (GPR) and design of bolt connections on an existing Reinforced Concrete Slab.

# **SCOPE OF WORKS:**

#### Background

The Hartebeestfontein water care works, situated in the central Drainage District (DD3), serves the majority of the communities and industries in Kempton Park, Bapsfontein and Pomona, as well as various other sections such as Serengeti and Jet Park. It is designed to treat some 63 Megalitres of wastewater per day.

The plant has recently faced a challenge with the aeration section of the plant where one of the Module 1 aeration gearbox disintegrated from the holding bolts. The disintegration is attributed to failure in the hold down bolts that are anchored into the concrete slab.

The services of a professional services provider are required to investigate and re-design the connection in order to re-instate the aeration system that is currently out of use. Due to the absence of existing drawings of the connection, the service provider is required to do ground penetrating radar in order to establish the design of the existing slab .this will ensure that the proposed position of the new anchor bolts does not punch into the existing reinforcement. Figure one below illustrates the failure that occurred due to suspected vibration of the aerator gearbox and electric motor.
